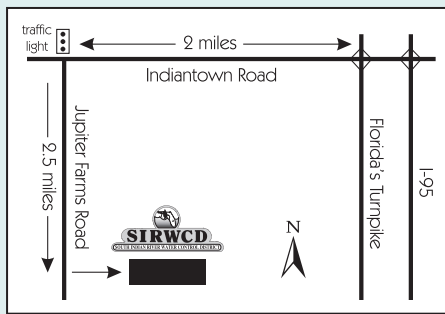

PALM BEACH COUNTRY ESTATES POTABLE WATER PROJECT CONTINUES

Phases 1A, 1B, 2A and 2B have been certified and placed into service. The landowners living within these areas have received mailings describing steps to hook up to the potable water system. Information on the project also is available on the District's web site at www.sirwcd.org.

In addition, all pipe installation for final Phases 3A and 3B has recently been completed. Testing and flushing of pipe in Phase 3A will begin soon.

The District would like to thank all residents for their patience during the construction of this large infrastructure project.

The District Engineer's field representatives continue to work with PBCE residents to address any questions. Landowners are encouraged to report any problems or issues regarding the potable water project to the District Office, or to the District Engineer at 772-219-2953.
